



## **Telkom #GimmeGIGS Terms & Conditions APRIL 2017**

- The competition is run by Telkom SA SOC Ltd, and is open to all members of the public 18 years or older who reside in South Africa except the employees and their immediate families of Telkom SA SOC Ltd, advertising and promotion agencies, distribution partners, associated companies, and outlet owners and their immediate families and staff associated with this competition.
- Winner(s) will be selected from all entries received randomly within competition period by an independent auditor appointed by Telkom. The judge's decision is final and no correspondence will be entered into.
- Winner(s) will be notified 1 week after the competition draw date. Each draw will take place on the 25<sup>th</sup> of each month. Should the 25<sup>th</sup> fall on a weekend or public holiday the draw will take place on the next working day.
