

## **Telkom Black Friday Promotion Terms & Conditions**

# 1. Telkom Black Friday Promotion (the "Promotion")

- 1.2 These Terms and Conditions, applicable to the Promotion must be read together with the Telkom SA SOC Ltd standard terms and conditions which can be found on www.telkom.co.za/terms/

#### 2. Promotion Period

2.1. The Promotion shall only be on **27 November 2015** only. (The "**Promotional Period**").
